Applications which are incomplete and do not meet the requirements will be held and returned back at the expense of the Applicant to re-submit his application at a later date once all the requirements are completed by the applicant.

Requirements for Single Entry Business Visa:

- 1. (3) Copies of Visa application form filled and signed by the applicant.
- (3) Recent Passport Size Photographs of the applicant with light background. 2.
- (3) Attested Photocopies of Passport of Applicant. 3.
- 4. Visa Processing Fee of Rs. 2700/= and (*Local Courier Charges Rs. 200/= *required if applicant requests the Passport to be returned by courier). [A Charge of Rs.2980/- applies if the Applicant Requests Urgent Dispatch of the Visa Application to Ethiopia]. Make Pay Order in favour of 'Jawed Arshad Con Gen Ethiopia'.
- 5. (1 Original + 2 Copies) Recommendation of (KCCI) Karachi Chamber of Commerce & Industry, or (FPCCI) Federation of Pakistan Chamber of Commerce, or related Association or governing body of applicant's industry/ business.
- 6. (1 Original + 2 Copies) Signed Letter from the applicant providing the reason of business-visit to Ethiopia.
- 7. (1 Original + 2 Copies) Invitation letter from Ethiopian Firm / Ethiopian Business whom the applicant intends to visit while his stay in Ethiopia. (Optional).

- 5. (1 Original + 2 Copies) Recommendation of (KCCI) Karachi Chamber of Commerce & Industry, or (FPCCI) Federation of Pakistan Chamber of Commerce, or related Association or governing body of applicant's industry/ business.
- 6. (1 Original + 2 Copies) Signed Letter from the applicant providing the reason of business-visit to Ethiopia and explanation of requirement for the Multiple Entry Business Visa supported by documented evidence.
